
What is Public Housing in France?

- Public housing or social housing in France (French: logement social, also called by generalization Habitations à loyer modéré or HLM) is a central, local or social program designed to provide subsidized assistance for low-income and poor people.
- The social housing sector in France accounts for about 18,4% of the stock.
- About 1,6% of the French GDP is dedicated to social housing, though the <u>demand is around 2%</u>.


Housing Traditions in France

- France has one of the longest traditions of social and state intervention in the housing market, since 1775!
- Royal Saltworks at Arc-et-Senans was built with a part dedicated to house workers.
- In the 19th century the cités ouvrières (company towns) appeared, inspired by the Phalanstère of Charles Fourier.
- After World War II the Government launched a huge construction plan, including the creation of new towns ("villes nouvelles") and new suburbs with HLM.
- France still retains this system, a law of 1998 making it an obligation for every town to have at least 20% HLM.

Income distribution of social-housing tenants between 1973 and 2006





- Although there is no single European model for social housing, there are nevertheless a number of common trends and features in most countries in Europe: delegation to local government, a new focus on fragile populations, reductions in the proportion of social housing.
- In France, the welfare state is tending to break with its "universalist" vocation in order to target action on increasingly vulnerable populations.
- The expectations for new housing for 2013: 280k-300k instead of 500k (the lowest level for 50 years!)
